unlawful processing and that I have the right to use the necessary information identifying my identity in order to use these rights. Personally submitting my request, including explanations about who, by filling out the form at www.ledin.eu and a signed copy of the form to the Company Directorate at the address of 15 Temmuz Mahallesi Gülbahar Caddesi Sancaktar Plaza No:128/11,34212 Bağcılar/İstanbul, with documents identifying my identity. I accept that I have the right to transmit it through a notary public or other methods specified in the KVK Law.

In addition, I declare that the personal data I have shared with the Company is correct and up-to-date; I agree and declare that if there is a change in this information, I will notify the Company of the changes. I expressly consent to the processing of my personal data, including my personal data of special nature defined in the KVK Law, to be used and shared within the scope of the relevant process, limited to the purpose of processing, and to be kept for the required period of time, and that I have been informed about this matter; I have read and understood this text, the Company's Personal Data Protection and Processing Regulation and the Clarification Text;
